Greetings. I hope you're enjoying your run at the Ballroom. I'll be there tonight and I look forward to seeing you.

I'm sending you my letter of November 12th because I'm not sure you received it the first time. I am still interested in presenting your acoustic set on our program AFROPOP WORLDWIDE. I know you have also been approached by another public radio show, Club del Soul, and I have talked with the producer, Karen Jefferson. She knows I am also requesting a recording, and she told me she does not have an exclusive agreement with you. So we both could present your live show. All modesty aside, AFROPOP WORLDWIDE is the established, highly regarded showcase for music from Africa, the Caribbean, and the Americas in U.S. public radio. We are carried by over 200 stations and have a listenership in the 100's of thousands. We have been on the air for five years now.

Please call me as soon as possible (hopefully this afternoon) to let me know whether you would like to do this because I have to let the recording crew know. The recording would be Wednesday, November 25th and we would need a sound check in the afternoon to make sure we're getting the best possible sound. My co-producer, Ned Sublette, and I will be there tonight to familiarize ourselves with your show. I have talked with Becko about handling the financial arrangements. He knows the quality of what we do. I have also talked with Tony Origlio and William McLaughlin. You will see our standard release form included in this FAX. Please call if you have any questions. I look forward to talking with again Gil. We would probably like to do a follow-up interview with you at your convenience to give us background information on the songs when we produce the program.
